The Board headed by the District Fire Officer, Fire & Rescue Service, Kannur had inspected the G + 2 Floor 9.90meter height Education Building in Survey No. 197/1A in Cheruthazham Village in Kannur District under Sri. **The Manager**, Mary Matha English School, Pilathara P.O., Kannur Dist. and recommended to renew no objection certificate No. G-1620/2021 dated 26.02.2021 of the regional fire officer. For the occupation of the said building as per Report no C119/2022 dated 28.02.2022 of the District Fire Officer, Fire & Rescue Service, Kannur for one year with effect from 28.02.2022.

In the circumstances, this No Objection Certificate is issued under my seal and authority for the continued occupation of the above building. No further construction will be allowed in the vacant spaces provided in the above plan.

The Certificate is issued on the condition that the fire fighting systems installed will be kept always functional and the owner of the building should take special care to maintained the systems installed in proper working condition. **This certificate is valid for one year from the date of issue. After one year the certificate must be renewed. No renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the local self government/Revenue Department.** All officers of and above the rank of District Fire Officers of the Fire & Rescue Department will have the right to inspect the building on any day/time after serving days notice to ensure that the installed systems are in good working condition.
